INVESTIGATIVE REPORT

THE 13TH DOOR
TIGARD, OREGON
DECEMBER 3 – 4, 2005

Southwest Washington Paranormal Research conducted an investigation of paranormal activity at the 13th Door, located in the old Regal Theatre of Washington Square in Tigard, Oregon.

The investigation included five members of the Southwest Washington Paranormal Research group along with two members of Northwest Paranormal and three guest investigators. Various equipment used in the investigation include: motion detectors, digital recordings, temperature readings, EMF detectors, and various digital cameras.

The researchers started the investigation by setting up the equipment and taking temperature and EMF readings throughout the theatres. EMF was detected only at the top of the stairs during the walk-through and read .2.

The following is a timeline of the events that occurred during the investigation:

9:20 pm Set up equipment: Camera in lobby next to theatre 1; motion sensor in theatre 3 (batteries already dead in motion sensor); motion sensor in theatre 1 within the maze.

9:54 pm Remote for motion detector went missing.

10:08 pm Kim notices that 2 of the toilet seats on the far right are up.

10:15 pm creaking noises heard in theatre 3

10:21 pm EVP Session begins in theatre 3

10:29 pm End of EVP Session.

10:30 pm At the end of the EVP Session in theatre 3 a cold breeze is felt. EMF detection went up to 10 while temperatures fell from 43* down to 39*

10:35 pm 2 taps are heard on the wall in Theatre 3.

10:42 pm EVP Session begins upstairs also using the pendulum.

10:47 pm Kim, Fred and Jan hear a women laughing

10:47 pm End of EVP Session

11:04 pm Cameras are moved and setup in theatre 4. Battery in camera is dead.

11:23 pm Jackie feels very nauseous. While Martina helps to ground Jackie the spirit told Martina "I'll kill you."

11:32 pm Will hears unexplained noises.

11:40 pm Jackie's nauseousness worsens and Jackie and Dennis leave.

11:45 pm EVP Session in Main Lobby

11:52 pm End EVP Session

11:52 pm Break up into groups: Group one – Fred, Jan, Kim and Angela. Group Two – Desi, Will, Martina and Todd.

11:59 pm Group 1 holds EVP Session in Theatre 4

12:05 am End of EVP Session

12:10 am While in Theatre 4 Group 1 hears knocking upstairs

12:12 am Kim found remote in red bag

12:44 am Groups rejoin upstairs and hold EVP session.

12:47 am A cat is heard meowing during EVP session.

12:56 am End of EVP Session
12:59 am EMF spike to 6-7 upstairs
1:04 am End of investigation.

The evidence gathered from the above mentioned equipment will be analyzed and posted on the web site. This is an ongoing investigation.
