

Equipment used: Audio recording devices, video cameras, digital cameras, thermal scanners & psychic impressions.

Base temperature in the downstairs area fluctuated between high 50's and low 60's. Second floor base temperatures fluctuated between high and low 50's.

Our team noted that the second floor had several "cold spots" and many times throughout this investigation felt a "draft" move past them as though a person walked by them, which of course no one had. At one point we heard music, & what sounded like crying from the second floor. One researcher actually witnessed a door open and close all by itself on the second floor. The first floor provided us with several moving orb photos. EVP was collected from both floors. Some researchers felt as though they were being chased or rushed up on at times near the stairs & bedrooms. Our psychic's impressions were that at least four spirits are present in this location. The first is a young man in some type of uniform maybe the army, and he seems to be pacing and very anxious about something, name may be Dan or Sam. The second is a little girl around 7 maybe named (Lillian rose, Lilly, something that starts with an L) who prefers the bedrooms and the stairs. She seems playful and content. The third is an older woman who may have been very ill in this house. Possible name may start with a C like Catherine, she prefers the bedroom areas. These 3 spirits seem playful but peaceful; they don't seem to mean any harm. The names are just impressions; they may not be there names at all. The fourth is a man who seems a bit hostile and stays in the basement most of the time. During an EVP session we got a strong urge to head down to the basement. Many of our researchers experienced a foul odor while down in the basement, one moment it was there and then it was gone. It happened in the far left corner of the basement around a hole. The feeling started to be very uneasy for all the researchers, & we knew it was time to call it a night. We aren't sure about him yet.

If at all possible in the future we would like to come back to investigate the basement area in more detail. Try to find out why he is there & what we can do to help put him at peace. We talked to all the spirits there & told them they were scaring you. We told them you already know they are there, & you are trying to live in peace with them. So there is no need to show themselves to you all the time. We asked them to listen to you when you ask them not to enter your bedroom. That is your part of the house & they are asked to stay out of there. We told them no matter how many times they

try to scare you, that it is your house now & they are still welcome to stay. You are not asking them to leave, just live in peace with you & not to scare you anymore. We hope our visit helped some of the scaring go away, & they will let you live in peace there. We don't feel they are bad at all just trying to be noticed, we told them it worked & now they can stop.

The old man that visited you in the bedroom not long ago, we feel is your basement old man. He is the one that is not at peace, maybe that's why he didn't smile at you like the older lady did. He defiantly has a darker side, where the other spirits there do not. The other spirits may even be a bit uneasy with him to. We feel that the spirits in the Bradley House are confused about the number of guests who pass through the doors of their former home. It may be helpful to let them know that the people are only coming to stay for a short while and the house is still theirs to.
