Southwest Washington Paranormal Research conducted an investigation of

paranormal activity at the Kelso Theatre Pub on May 21 and 22, 2005. This investigation is an ongoing investigation.

The investigation included six members of the Southwest Washington Paranormal Research group. Various equipment used in the investigation include: motion detectors, digital recordings, temperature readings, and various digital cameras.

Upon arrival of the theatre Angela believed she saw an apparition in the lobby of the theatre around 10:20 PM: an elderly man with thinning white hair wearing a dark suit standing in the lobby.

The researchers started the investigation by setting up the equipment and taking temperature throughout the building. The temperature read 64°F - 66°F throughout the theatre except in the following locations: lobby 68°F; stage right on stairs 62°F; back of stage 63°F; stage left 62°F; ladies' room 62°F; men's room 63°F; projector room 68°F; lower right upstairs balcony 67°F.

Video cameras were set up in the projector room and on the stage. The motion detector was placed in the ladies' restroom.

The following is a timeline of the events that occurred during the investigation:

10:20 PM - Angela sees apparition in the lobby
10:50 PM - Set up of equipment and discussions with Manager
12:05 AM - EVP Session 1 in Main auditorium by Dez
12:16 AM - End of EVP Session 1
12:19 AM - Played music in main auditorium on stage
12:24 AM - Angela heard someone whisper "stop" from the stage - Stacie then claimed to hear it as well from the entrance of the auditorium
Cold breeze is felt near the stage
12:30 AM - Kim arrives at investigation
12:41 AM - 2nd EVP session upstairs in lobby area
12:50 AM - End of 2nd EVP session
1:20 AM - 3rd EVP session in entrance area of auditorium
1:30 AM - End of EVP session 3
1:31 AM - Kristie felt "light headed" in men's restroom
1:33 AM - EVP session 4 in ladies' restroom

During this EVP session Kim and Fred saw light moving from the entrance of the restroom as if someone was moving outside of the restroom

1:44 AM - End of EVP session

1:45 AM - EVP session 5 in Men's restroom

1:50 AM - End of EVP session

During EVP session Fred saw a black cat in men's restroom (there was no cat)

1:51 AM - 2 AM - played more music in main auditorium

2 AM - EVP session 6 held in upstairs balcony

During this EVP session footsteps are heard, whispers are heard, Dez thinks she sees someone on the stage, a cold breeze is felt

2:11 AM - End of EVP session

2:13 AM - The team was sitting in the upstairs balcony just after the EVP session. A loud squeak and a door slam was heard by everyone. The lights in the upstairs lobby then flickered immediately afterwards. After extensive investigation it was concluded that all the doors on the outside into the theatre were locked and no one else was inside. It was also concluded that the squeaky door everyone heard was a door to a stall in the ladies' restroom.

2:25 AM - Kristie heard something upstairs - Fred, Kim and Kristie then started to go up the stairs and heard someone.

2:30 AM - All lights flickered

2:35 AM - EVP Session 7 upstairs in lobby. Dez sees blue in the ladies' restroom

2:44 AM - End of EVP session

2:55 AM - Team sat in upstairs auditorium with tape recorders on and then started an EVP session

3:10 AM - End EVP Session

3:39 AM - EVP Session in upstairs lobby

3:44 AM - Kristie felt cold breeze on face.

3:59 AM - End of EVP Session

4:00 AM - End of investigation

The evidence gathered from the above mentioned equipment will be analyzed and posted on the web site. This is an ongoing investigation.
